Jane would like to register their child for the Applegrove After School Program.

Jane has 3 people in their family.

Jane and their partner have a combined income of \$37,000.

Jane and their family qualify for a level 4 subsidy.

Based on the family income and size, Jane would pay a subsidized fee of \$168 per month.
